He has successfully guided companies through complex legal disputes, securing courtroom victories and favorable resolutions that protect their business interests.

Chris has shared his expertise through various avenues, including publishing the practice guide *Texas Trade Secret Litigation* and teaching as an adjunct professor of antitrust law at SMU Law School. He is also the editor in chief and a frequent contributor to the ABA's *Litigation Journal*, writing on key developments in commercial litigation, trial strategy, and legal history. REPRESENTATIVE MATTERS

- Represented ***Energy Transfer*** in a \$150 million lawsuit brought by investment funds associated with Goldman Sachs alleging fraud, breach of contract, and negligent misrepresentation related to pipeline development delays. After a three-week bench trial in New York Supreme Court, obtained a complete defense verdict on all claims.
- Represented ***Blackstone, Inc.*** in the first contested final judgment under the new Texas Business Court system. Obtained summary judgment resolving breach of contract and fiduciary duty claims brought by minority investors in Primexx Energy Corp. relating to the \$788 million sale of an affiliate oil and gas business.
- Represented a ***Keurig Dr Pepper*** in a breach of contract and tortious interference lawsuit concerning an asset purchase agreement and earnout payments. The plaintiff alleged that the company failed to take commercially reasonable efforts to maximize sales and intentionally limited investment in the acquired brand. Successfully obtained dismissal of all claims in Delaware Superior Court, with the court finding that the contract did not impose the obligations the plaintiff sought to enforce.
- Advised a ***multi-national manufacturing joint venture*** on antitrust compliance and governance design, including identifying structural risks arising from dual distribution roles, competitively sensitive information flows, and seconded employees; developed and implemented remedial protocols, committee structures, and information-sharing guardrails to mitigate exposure while preserving procompetitive efficiencies.
- Represented an ***online travel agency*** in an antitrust lawsuit brought against the eight largest hotels in the United States and, on summary judgment, convinced the court to apply the per se antitrust standard to the bid rigging and group boycott allegations—the first time any court has made such a finding in the context of online advertising auctions and successfully settling with all eight defendants.
- Advised an ***ecommerce company*** on antitrust implications of integrated product offerings and subscription models, including analysis of single-product vs. tying frameworks, consumer choice dynamics, and procompetitive justifications in digital platform ecosystems.
- Represented a ***leading beverage company*** and won summary judgment on contract claims involving a business dispute between the client and its specialized ink supplier.
- Represented a ***practice of orthopedic surgeons*** in a long-running arbitration against a former physician. Secured a complete victory, including 100% of the damages sought, attorneys' fees, and an award requiring the departing doctor to indemnify the practice for the full amount owed under a separate hospital recruiting agreement.
- Represented an ***alternative energy company*** in a fiercely contested trade secrets case involving

the theft of sensitive competitive information, successfully fending off multiple summary judgment motions and convincing the court to strike all the defendant's experts, all of which led to a highly favorable confidential settlement.

- Represented a **co-packing and co-manufacturing company** for leading alcohol & beverage brands and obtained a broad temporary restraining order preventing former executives from misappropriating trade secrets, ultimately leading to a highly favorable early settlement.
- Representing an **executive** in a securities arbitration regarding stock option transactions, and not only winning significant damages but also obtaining an attorneys' fees award.
- Represented a **pipeline company** in a breach of contract case and, after three years of litigation, obtained complete dismissal of the plaintiff's claims by arguing that the claim belonged in an administrative proceeding such that the district court lacked subject matter jurisdiction.
- Represented a **national law firm** defending against legal malpractice claims and obtained complete dismissal on summary judgment on statute of limitations grounds.
- Represented an **oil and gas investor** alleging claims of fraud and breach of contract against a former operator and, after winning injunctive relief, settling the case on favorable (but confidential) terms.
